Mayor Chorley led a silent moment of reflection.

6. DELEGATIONS AND PUBLIC HEARINGS

6.1 RCMP Report

Sgt. McKinnon reviewed the RCMP Incident Report for September 2015. He noted that the RCMP have recently arrested three Hampton youth in relation to at least 18 instances of mischief, theft, trespassing and vandalism in the Hampton area over the summer.

6.2 Kennebecasis Valley Oasis Youth Centre

Yennah Hurley presented to Council on behalf of the Kennebecasis Valley Youth Centre. They hope to open the Oasis Youth Centre in the Kennebecasis Valley in May 2016 with a goal of providing a safe, comfortable, accessible, multifaceted and stigma free space in which to promote activities and programs that enhance and develop youth in the KV and surrounding area including Hampton and the Kingston Peninsula. The centre would promote health, wellness, recreation, artistic expression, intellectual inquiry, skill development and enjoyment for youth. Ms. Hurley stated that our youth have a lot to deal with, including: abuse, academic issues, anger, birth control, bullying, career planning, drug and alcohol problems, body image, and mental health concerns to name a few. They are targeting the 12-25 age bracket. The centre will include hang-out spaces (Games Room, Kitchen for cooking classes), rented offices for counsellors, sexual health nurse, social workers, psychologists and physicians, and larger event space. These professional pillars will be a revenue source. The centre would be located on the Pettingill Road in the former French school. Ms. Hurley stated that they would be launching a Capital Campaign this fall with a goal of raising a million dollars. These funds would be used for their operations for the first three years. She said the proposed model is sustainable as the centre would be a pay-per-use model. There would be subsidies available for those who require it. They were asking the Town to consider donating ten thousand dollars (\$10,000.00) per year for three years.

Moved by Deputy Mayor Doucet and seconded by Councillor Bond that the request of the Kennebecasis Valley Oasis Youth Centre be referred to the Finance Committee for consideration in the 2016 Budget.

BLUE DOT MOVEMENT

In light of the fact that the Town of Hampton has adopted environmental policies and procedures through our Municipal Plan and our Integrated Community Sustainability Plan, as well as through our Town Motto "It's Our Nature", that state our commitment to our beautiful and unique natural environment and our understanding that a healthy environment is inextricably linked to the well-being of our community, and whereas the Town has already taken many concrete actions to ensure safe water, beautiful open spaces, clean streets and well-planned development, it is moved by Councillor Behr and seconded by Councillor Bond that it is not necessary at this time to join the Blue Dot Movement, but that the Town will continue with our mandate to provide our residents with a healthy environment in which to live as well as continue to monitor the Blue Dot Movement and their initiatives.
