6.1 <u>RCMP</u>

They reported that the locations of check stops are often moved so that people do not become familiar with their locations. Council inquired about the 14 false alarms on the report, the constables stated that these were primarily weather related.

6.2 <u>Rezoning Request – Logie Drive PID 00194803</u>

It was noted by Councillor Beach that a Rezoning Application for PID 00194803 (94 Logie Drive) was received by Propertystar Inc. on March 3, 2016, requesting that Council consider rezoning the abovementioned parcel from Residential to Commercial 1 for the purposes of developing a storage unit facility that would house approximately 50-100 units (unit sizes ranging from 8'x 8' to 10' x 12').
