6. DELEGATION AND PUBLIC HEARINGS

a. <u>Andrew Logan, Auditor from Teed Saunders Doyle & Co.</u>

b. <u>Public Hearing – Rezoning Request for 1032 Main Street</u> The Mayor called the Public Hearing to Order.

> The Building and Development Officer presented a summary of the proposed amendment. The Rezoning Application for PID 00434704 (1032 Main Street) was received by Lifestyles Health and Fitness Centre on January 18, 29017, requesting that Council consider rezoning the abovementioned parcel from Institutional to Town Centre for the purposes of locating a fitness and wellness centre in the current building. Currently the lot contains one institutional building that is occupied by the Royal Canadian Legion.

> The Building and Development Officer noted that this public hearing was advertised in accordance with the Community Planning Act and that she provided written notice to property owners within 100 meters of the proposed rezoning. In addition, she noted that the written opinion had been received by the Planning Advisory Committee and it was to recommend that Council move forward with the rezoning of PID 00434704, further defined as 1032 Main Street.

The Mayor asked three times for all those who wished to speak on the amendment to present themselves at the podium.

As there was no one that wished to speak, the Public Hearing was adjourned.

11.4 Leisure Services Advisory

Deputy Mayor Doucet gave an overview of the Leisure Services Advisory Committee minutes. He noted that they are still looking for a student representative for the committee. He announced that this year the Town will kick off Canada Day with a Comedy Cabaret featuring James Mullingar. The Town is now accepting student applications.
