6.1 Hampton RCMP

Sgt. Rodier stated that the month of May was busy especially with the *May Run*. They collaborated efforts the Saint John and Kennebecasis Valley Police forces. In addition she noted that two check stops were conducted in May with approximately 75 vehicles checked. The check stops were on Kennebecasis River Road and Lakeside Road.

6.2 Kings County Museum

Richard Brown provided Council with an annual update on the Kings County Museum. He noted that the summer of 2016 was very busy, with 950 people signing the guestbook. He stated that they have had three directors in the course of the year. He indicated that all were very good but their limited staffing budget means that there is often a high rate of turn over. Mr. Brown said that the pivotal piece for 2017 is the return of the *Confederation Quilt*. He noted that returning the quilt was quite an ordeal. The quilt required a specialized art courier, a specialized case had to be constructed and then on arrival the quilt would not fit through the door so some modifications needed to made. The museum is asking the Town for advice as to hours of operation for the winter months.
