In attention she has implemented a "pop-up VIC" strategy where students will be setting up a tourism booth at local events. It was noted that new vendors have been introduced to the VIC Gift Shop.

11.4 <u>Health Care</u>

The Town CAO provided an overview of the Health Care minutes. He noted that Epi-Pen training has been completed at Lifestyles Health and Fitness. He also mentioned that both clinics scheduled for May were cancelled. The flooding was attributed to some registered participants not being able to attend and cancelling prior to the clinic.

The committee discussed the health implications of the recent flooding. The CAO reported to the committee that the Town of Hampton was very active on social media and door to door notices promoting Provincial Links regarding health risks associated with the flooding. Well test kits continue to be available at the Hampton Service NB office for our residents. The Town of Hampton gave out potable water to anyone in need and continue to have it available even though the demand has diminished.

11.5 Planning Advisory Committee

The Planning Advisory Committee reviewed and granted a variance request for 209 Pickwauket Road (PID 30223093) to allow for the construction of an oversized garage as the request is deemed desirable for the development of the property subject to the following condition: the garage is for personal use only and not intended to be used for business purposes.
