1. CLOSED SESSION

- j) Labour and employment matters, including the negotiation of collective agreements 1

The Town CAO reviewed the Health Care minutes with Council. Doctor recruitment continues to be a priority. The medical brochure is available for circulation and was recently sent to the NB Medical Society at their request.

11.3 EMO

Councillor Bond reviewed the EMO minutes including updates on the flood contingency plan, 72 Hour preparedness, Vulnerable Person Registry and Sentinel training.

The Mayor thanked personally Keith Copeland, EMO Coordinator, CAO Richard Malone, Councillor Dwight Bond, Mike Raeburn – Director of Public Works and Utilities, and Megan O'Brien Harrison, Communications Officer for their roles during the recent flood.

11.4 Environment

Councillor Behr provided an overview of the Environment Committee minutes.

Moved by Councillor Beach and seconded by Councillor Behr that the Environment Committee draft a resolution for Council to consider a support of a Provincial single-use plastic bag ban.

He noted that Luke McGregor of Matchstick Beer Factory was granted a temporary development variance for his property at 52 St. Andrews Street to fill growler bottles from his nano-brewery.

Councillor Beach also removed that a variance was granted for street frontage and setback for 52 Hilltop Drive.

Moved by Deputy Mayor Doucet and seconded by Councillor Behr that the Town of Hampton accept the reports from the Fire-Rescue, RCMP, Health Care, EMO, Environment, Planning Advisory and Human Resources Committees as submitted.

Councillor Bond reviewed the Building Inspector report.

12.2 Communications Report

The Communications Officer provided an overview of the Communications Report. She noted that the launch of the Tourism video was very successful and that social media had been an effective tool in getting Town messages out during the recent flooding.

14.1 Tender

The waiting period for the benefits package will be waived to the degree permitted by the Town's coverage provider. Her rate of pay is according to Schedule "A" Wage Scale – Leisure Services Administrative Assistant, dated May 14, 2019.

14.4 Regional Facility

Moved by Deputy Mayor Doucet and seconded by Councillor Beach that the Town of Hampton submit an expression of interest form to the Integrated Bilateral Agreement for the Investing in Canada Infrastructure Program (ICIP) for the Hampton Regional Multipurpose Facility.
