## 5. PUBLIC HEARING AND DELEGATIONS

## Sgt. Steve Gourdeau, Hampton RCMP

Sergeant Gourdeau reported that during the Christmas season, being the weekend prior to Christmas until New Year's Day, the RCMP responded to 87 complaints. The majority of the complaints were in the Town limits or immediately surrounding the municipality. The complaints ranged from domestic disputes, to drinking and driving, to fights, including bar brawls. Several members indicated that this was the busiest week they had recalled having.

He indicated that he is working with Town Staff on amending the Noise By-law. He was happy to report that David Lutz has agreed to have Lutz Longstaff work with the Town on developing the new by-law. Lutz Longstaff will be donating their time and will draft the By-law free of charge. Lutz Longstaff is responsible for prosecuting any municipality enforcement that the RCMP may do in Hampton.

Sergeant Gourdeau reported that there have been very few speeders on Kennebecasis River Road, though certainly some individuals had been caught speeding. He also noted that the new school speed zone is working well.

## 14. NEW BUSINESS

### 14.1 Hampton Diner

Councillor Chorley stated that the Town of Hampton went to great lengths to acquire PID 30183776 to be used as a Town Common and not for commercial use. He stated that when CNR owned this parcel of land, it was very clear to the owner of the Hampton Diner building, that the property owner could ask that the building be removed at any time. The Town of Hampton is simply carrying on the same terms. It is noted that the Hampton Diner building owner has been uncommunicative with the Town of Hampton regarding signing a lease agreement until this point. He is now willing to enter into a lease agreement. Providing an extension to October 2008 would allow Ms. Lights to operate her ice cream business for an additional summer from its current location, as well as allow the tenants of the building to make arrangements for alternative locations of operation.

Councillor Bond stated that he agreed with what Councillor Chorley stated.

Moved by Councillor Bond and seconded by Councillor Chorley that the Town of Hampton rescind a previous motion in regard to the Hampton Diner, made at the regular Council meeting of December 11<sup>th</sup>, 2007, in light of the fact that the owner of the Hampton Diner building has requested the extension and is now willing to sign a lease, which reads as follows:

Moved by Councillor Chorley and seconded by Councillor Bond that given the fact that the Hampton Diner Building, located at 619 Main Street, has the status of a "holdover" tenant, that the Town of Hampton provide written notice to the Hampton Diner building owner, Ross Lights, that the Hampton Diner Building must be removed from town property (PID 30183776) by the 30<sup>th</sup> day of April 2008. Until that time Mr. Lights will be required to make monthly lease payments at the existing rental rate.

Once rescinded a new motion was made.

Moved by Councillor Bond and seconded by Councillor Chorley that given the fact that the Hampton Diner Building currently has the status of a "holdover" tenant that the Town of Hampton provide written notice to the property owner, Ross Lights, that the Town of Hampton will extend the deadline to remove the Hampton Diner building from Town property (PID 30183776) from April 30, 2008 to October 30, 2008 provided that Mr. Lights enter into a non-renewable lease agreement with the Town of Hampton, the terms of which were previously presented.

Mayor Hovey stated that after a great deal of thought, he has decided that he will not reoffer for the Mayor's chair in May 2008. He indicated that he has enjoyed his time on Council – three terms (9 years) as Deputy Mayor, and sixteen years as Mayor – for a total of 25 years when this term is complete in May. He has seen a great many changes in Hampton, all for the better of the Town, and he is proud of the accomplishments that have taken place. Mayor Hovey stated that he has had a great change in his life with the death of his wife six months ago, and this has assisted in making his decision not to reoffer. He wanted people to know his decision as early as possible, so that potential candidates, including present councillors, could consider the challenge. He thanked all the Councillors that he has served with over the years and all the staff that he has worked with. He stated that it has been a great run.
