Councillor Doucet noted that they have completed a topographical map of the proposed skateboard park site and would be taking it back to the committee.

Councillor Doucet noted that the issue regarding the unpleasant rink odour has yet to be resolved. Two cracks were discovered in the pipes and have been repaired by the odour is still noticeable. The Town is proceeding with further investigations into the problem.
