6. PRESENTATIONS AND DELEGATIONS

Inspector Warr – RCMP report

Inspector Warr referenced his correspondence to the Town of Hampton regarding the interim staffing arrangements in light of Sgt. Bruce Reid's transfer to a different position. Inspector Warr is currently doing double duty in Hampton and Sgt. O'Connell is in Sussex until a replacement is named.

Inspector Warr noted that June was a quieter month than the same month in the previous year. He stated that there was a complaint of luring a minor over the internet. The incident involved a Facebook account. A computer was seized and the investigation continues.

Inspector Warr asked Council to note that the RCMP report should be amended to indicate that there were three check points this month in Hampton not one.

He stated that the mobile speed sign was up and working several times in June, including in the newly reduced speed zone on Main Street.

Inspector Warr talked about criminal record checks and the safe guards regarding the sex offender registry.

Members from the Hampton detachments were in attendance at the Hampton High School graduation in their red serge. Mayor Chorley also thanked the Inspector and his members for their attendance at the Town Square Grand Opening and the Canada Day festivities.

Inspector Warr reported that they have received several noise complaints from the Shiretown Publicans. Three charges were laid this past month.

Council stated that there were still some hiccups with traffic following the fireworks. Inspector Warr recommended that the Canada Day committee contact the detachment for planning for the 2012 event.

Council requested increased surveillance of the Town Square to discourage skateboarding and biking on the Town Pavilion.

Rick Rogerson, 74 Dutch Point Road

Mr. Rogerson stated that he has serious concerns about the high volume of high speed traffic on Dutch Point Road. He is afraid to have his grandchildren walk along the road. He understands that Council got flack for installing speed bumps on Dutch Point in the past, but he hopes Council will consider installing them again. It was suggested that smaller ones might be a better option. Council referred the matter to the RCMP and the Public Works Advisory Committee for a recommendation.
