1. CLOSED SESSION

2. REGULAR SESSION – PUBLIC COUNCIL MEETING

Mayor Chorley called the Open Session to order at 7:05 p.m.

3. MOMENT OF SILENCE AND MOMENT OF REFLECTION

Councillor Behr led Council in a moment of reflection.

4. DISCLOSURE OF CONFLICT OF INTEREST

Deputy Mayor Bond declared a conflict of interest on all issues dealing with land development in the Town of Hampton.

5. PUBLIC HEARING AND DELEGATIONS

Sgt. Steve Gourdeau, RCMP

Sgt. Gourdeau noted that there has been an increase in motor vehicle break and enters in recent months. He advised residents to lock their vehicles. He planned to put an article in the Hampton Herald and Telegraph-Journal regarding this issue.

He stated that the RCMP would be willing to work with the organizers of the Town Wide Yard Sale to assist with the issues of parking and traffic flow.

He also noted that there were some staff changes in their office as two officers had been transferred.

Joe Kennedy, Wildlife Biologist, Provincial Department of Natural Resources

Council invited Mr. Kennedy to speak on potential responses to the nuisance deer problem in the Town of Hampton. Council believes these deer have become more than a nuisance and raised safety concerns, citing the potential for motor vehicle collisions and Lyme disease.

Mr. Kennedy provided an overview of deer population statistics for the Kennebecasis Valley region that includes Hampton. He stated that factors that favour the deer population in the municipality are mild winters, reduced harvest of does, abundance of food, feeding of deer, and lower numbers of predators near humans and reduced hunting pressures.

He stated that concerns with overpopulation are reduced body size due to food competition, increased spread of disease, increased public concern, public safety issues, and damage to crops and ornamental gardens.

Mr. Kennedy noted that deer are living within the Town limits year round because of the food source. They have changed their behaviour to tolerate humans because there is a stable food source and less predatory pressure in the municipality. He stated that feeding the deer commercial deer pellets greatly adds to the problem.

He stated that the Department of Natural Resources (DNR) agrees the deer population must be controlled, and have increased the harvest levels of antlerless deer for this hunting season in recent years.

DNR is also making changes to harvesting with archery equipment within urban areas, balanced with public safety issues, as a means to control the urban population. For the upcoming deer hunting season, Kennedy said the shooting zone for archers has been changed from 200 metres to 100 metres to allow more urban harvesting. Kennedy noted that archers still have to get permission from property owners before hunting on private land.

DNR does not trap and relocate nuisance deer. This technique is ineffective when dealing with large numbers. They would not recommend this option to the Town of Hampton. Other options such as darting them with birth control or hiring a professional sharpshooter are not practical financially. He noted some options were fencing, chemical deterrents, selective planting and a municipal by-law banning feeding of deer with commercial deer pellets.

Council thanked Mr. Kennedy for his presentation and directed staff to explore the possibility of a Municipal By-law.

Moved by Councillor Lights and seconded by Councillor Doucet that prior to approving the tentative plan, Orchard Hills Subdivision Overall Scheme, dated April 21, 2009, as prepared by Keirstead, Quigley and Roberts Ltd, the Town of Hampton advise the developer that the following conditions must be addressed:

- Adjustment to Land for Public Purpose;
- Proof of a written agreement between AMH Properties Limited & St. Paul's Church;
- The creation of another road off Viola Avenue between Lots 41 and 42;
- AMH Properties Limited securing necessary sanitary sewer easements and providing written proof of same;
- Review of Plans by the Town's Environment Committee; and
- The satisfactory completion on an Environmental Assessment of the property;

The approval of the tentative plan will be conditional on the following:

- Application will be made to the Planning Advisory Committee for any variances once the field survey has been completed;
- Proof of transfer of the property in question from George Demille to AMH Properties Limited;
- Individual phases of Orchard Hills are subject to final approval of Council and will require the execution of the developer's agreement between the Town of Hampton and AMH Properties Limited;
- Placement of appropriate bonding as determined by the Town Engineer, Godfrey Associates;
- Final Subdivision Plans to be signed by appropriate Utilities;
- and the satisfactory completion of a Comprehensive Water study

As recommended by the Planning Advisory Committee, Utilities Commission, Public Works Advisory Committee, Leisure Services Advisory Committee, and Town Staff. It is noted that the plans are still subject to the review and recommendations of the Town's Environment Committee.
