1. CLOSED SESSION

In accordance with Section 68(1) of the *Local Governance Act*, Mayor Chorley called the closed session to order at 6:00 p.m. and adjourned the closed session at 7:00 p.m. During that time, a number of issues were discussed and the confidential information from such discussions was classified as follows:

2. OPEN REGULAR SESSION

Mayor Chorley called the meeting to order at 7:03 pm.

3. SILENT MOMENT OF REFLECTION

Mayor Chorley led Council through a silent reflection.

4. APPROVAL OF AGENDA

Moved by Councillor Beach and seconded by Deputy Mayor Doucet that the agenda of the July 14, 2020 Council meeting be approved as presented.

5. DISCLOSURE OF CONFLICT OF INTEREST

Mayor Chorley asked that anyone who has a conflict of interest declare it when they reach that item on the agenda.

6. DELEGATIONS AND PUBLIC HEARINGS

6.1 Constable Matt Beaulieu, Hampton RCMP

Constable Beaulieu reviewed the June RCMP report with Council. When asked, he explained that difference between non-reportable accidents and reportable accidents. He stated that accidents occuring in parking lots and with damages under \$1000 would be non-reportable accidents.

He stated that they have now adopted an electronic ticket model which is working very well. There has been a focus on increased enforcement of speed limits on Centennial and St. Paul's Street. The Town CAO noted that the Town is getting speed complaints on Lakeside Road and Rockcliffe Drive.

He spoke brief on the recent damage at the sports field at Hampton Middle School. They are working on this. In addition he noted that a recent firearms complaint in the Hampton Trailer Park was unfounded.

6.2 Cathy Simpson, Advisory Council on Regional Economic Development

Cathy Simpson provided an overview of the proposed Regional Economic Development model. She noted that the objective was a new innovative approach to regional economic development that aligns the key players in the ecosystem focused on economic growth. She noted that this is not able consolidation to achieve cost efficiencies. The focus is on growth. This new economic development model will be funded regionally in the Greater Saint John area. The vision for the approach is one organization, one leader, one board, one budget. There would be four broad areas for economic development collaboration — Economic development, People attraction and population growth, Tourism development and Infrastructure development.

The board will consist of inside municipal/government directors and outside private sector directors. The chair will be an outside director. The inside directors will be appointed by the municipalities from senior staff members. There will be no elected representatives sitting on the board. Municipalities will have preferred shareholder status.

Hampton will have one vote. She stated that they hoped the new organization will up and running in January.

Councillor Beach commended Cathy Simpson and David Campbell on the work that they have done. He noted that getting people to collaborate is never easy and he appreciated their effort.

11.3 Fire-Rescue

Councillor Bond reviewed the Fire-Rescue report for June.

11.4 Planning Advisory Committee

Councillor Beach provided an overview of the PAC report.

He noted that a variance was granted to BCY Development for lot road frontage for an apartment-style condominium building on a subdivided lot off Mapleview Drive. Roadways on the lot will be considered privately-owned driveways.

Councillor Beach reported that a variance was granted for an oversized garage for 96 Norton Shore Road (PID 30157267).

Moved by Councillor Beach and seconded by Deputy Mayor Doucet that the Town of Hampton, as recommended by the Planning Advisory Committee, approve the request of 697800 NB Corp., for cluster development for two 12 unit-apartment buildings at 153 Demille Court, identified as PID 00189415 subject to the following:

- i) that Town of Hampton staff will proceed with the drafting of a Developer's Agreement
- ii) that a minimum of a 30m buffer be maintained on either side of the watercourse on the property;
- iii) that the treed areas indicated on the site plan DE14401RO be retained
- iv) that a landscaping plan for the area around the buildings be submitted to the Development Officer for approval
- v) that a stormwater retention pond be established in the area indicated on the site plan to meet the net zero discharge requirements specified in the Town of Hampton Stormwater Management Guidelines that the Developer provide detailed engineered drawings to show how the net zero discharge requirements will be met prior to construction of the pond,
- vi) that the Developer submit to the Development Officer for approval plans detailing the naturalization of the stormwater retention pond.

Councillor Beach reviewed two sets of minutes for the Economic Development and Tourism Committee.

11.6 Tourism Subcommittee

Councillor Beach provided an overview of the Tourism Subcommittee. He noted that the Tourism Coordinator has produced a 2020 Visitor Guide for distribution.

11.7 Public Works Advisory and Utilities Commission

Moved by Councillor Bond and seconded by Councillor Beach that the request from Robert Young and Wayne Wolfe, on behalf of Hampton Seniors Resource Centre, to forgive a portion of their santitary sewer bill be denied but that it be referred to the accounting department to establish a reasonable payment plan.

11.8 Health Care

The Town CAO reviewed the Health Care minutes with Council including updates on doctor recruitment and looking into what needs to be done to keep a blood collection service in Hampton.

11.9 Leisure Services

Deputy Mayor Doucet reviewed the Leisure Services Advisory Committee minutes, noting changes in programming due to COVID-19. Friday night movies are now being held in the Hampton Community Centre. There is also Pickleball twice a week and the pool is operating. All activities require preregistration and screening.

Moved by Councillor Beach and seconded by Deputy Mayor Doucet that the Town of Hampton accept the reports from EMO, Fire-Rescue, RCMP, Planning Advisory, Economic Development and Tourism, Tourism Subcommittee, Public Works Advisory and Utilities Commission, Health Care Committee, Leisure Services Advisory and Joint Health and Safety Minutes as submitted.
