### 6. DELEGATIONS AND PUBLIC HEARINGS

### 6.1 Budget Presentation

Sherman St. Germain, Town Treasurer presented the proposed Town Budget for the General and Utility Fund Operating and Capital Funds. He stated that the Town of Hampton Tax Base is increased to \$6,742,150 which is an increase of 1.81% from 2020. The Community Funding & Equalization Grant will be \$203,115, which is a decrease of \$14,354 from 2020. It is proposed that the Tax Rate be held at \$1.2970 per \$100 of assessed value.

2021 Enhancement List that was recommended the Finance Committee includes items such as an electric Zamboni, guard chair, Wayfinding Signage, Replacement Chimney for the Town Hall, Generator for the Town Hall, Replace the Electronic Heating System in the Centennial Building, Municipal Plan and William Bell Development Scheme, Aerials Updates for GIS, Double Drum Roller and Roller Trailer for Public Works Department and programming for Age-Friendly Community initiatives.

It was noted that the Finance Committee is recommending discontinuing the COMEX service on December 31, 2020 and to not have day camp in 2021 due to COVID restrictions.

Moved by Councillor Bond and seconded by Deputy Mayor Doucet that the Town of Hampton approve the following rates for 2021, as recommended by the Finance Committee:

Program Registration, Arena rentals and Sport Field Prices;

Lighthouse River Centre Rental Rates;

Permanent Employee Wage Scale;

Summer Staff Wage Scale;

Rate Structure for Building Permits; and

Water and Sewer Charges, as recommended by the Finance Committee.

Moved by Deputy Mayor Doucet and seconded by Councillor Beach that the Town of Hampton end their commitment with Saint John Transit to fund any revenue shortfalls resulting from the operation of the rural to urban public transit service (Hampton COMEX) effective December 31, 2020 due to increased costs and low ridership, acknowledging that our formal commitment to Saint John Transit ended March 31, 2013.

Moved by Councillor Bond and seconded by Deputy Mayor Doucet that the Town of Hampton approve the tax rate for 2021 of \$1.2970 per \$100.00 of assessed value, pending approval of the Provincial Government. The gross expenditures will be \$6,241,162 less non-tax revenue of \$1,153,157 for a net budget of \$5,088,005 less the community funding and equalization grant of \$203,115 with a warrant to be raises by local rate of \$4,884,890.

### 6.3 Disc Golf Proposal - Bryan Neary

Bryan Neary stated that the Kings County Disc Golf Club (KCDGC) is proposing the installation of a 9 or 18 hole Disc Golf course in Hampton at the Dutch Point Park. He stated that the total cost of the project is estimated to be \$11,000 for a 9-hole course and \$25,000 for an 18-hole course.

He stated that disc golf course brings a sense of community for people who regularly use it. It encourages outdoor exercise 12 months a year and offers a creative outlet for players and organizers. As of September 2020 there are now more than 7000 disc golf courses in North America. The majority of these courses are installed or purchased by city and municipal parks and recreation departments. Disc golf has relatively low capital and maintenance costs compared with other recreational installations.

All public courses located in the Maritimes are located in public access parks. Areas such as Lakeburn Park in Dieppe, Beech Hill Park in Sackville, Odell Park in Fredericton and Coronation Park in Bathurst just to name a few.

He stated that the installation of a Disc Golf course would be a great addition to the Town of Hampton and allow for another recreational activity for the patrons of the park.

Mr. Neary stated that Disc golf is played much like traditional golf. Instead of hitting a ball into a hole, you throw a frisbee disc into a supported metal basket. The goal is the same: to complete the course in the fewest number of shots.

Moved by Deputy Mayor Doucet and seconded by Councillor Beach that the Disc Golf Proposal be referred to the Leisure Services Advisory Committee for review and recommendation.
