
# 14.4 Railway Improvement Grant

Proposed location of the sign to be reviewed on site by Director of Public Works and Utilities and the Town's Development Officer prior to issuance of any permits and installation of sign support structure,

Site distances for the existing driveway shall be maintained, and The Town has no responsibilities for the maintenance, upgrade, or repair of the sign and/or support structure and may request the Owner to remove the support structure with sixty (60) day notice, and as such, the Owner shall comply with the request.
