# 2. Approval of Agenda

#### 5. Old Business

# a) National Climate League – Presentation to Council

Laura Myers updated the Committee on her presentation to Council in June. The presentation asked Council 3 questions: 1. Does Hampton want to participate in the National Climate League (NCL) next year? 2. If so, do we collect data for Ward 2? 3. Which indicators could we complete before the next report? The Committee will be looking for answers from Council to these questions in the spring when NCL will be completing the next round of the inventory.

# b) Light Pollution Update

Staff provided an update to the Committee on recommendations that were sent to council about light pollution. Council moved that staff consider aligning the Hampton Zoning By-Law lighting requirements with recommendations from the Royal Astronomical Society of Canada for new development, as part of the housekeeping amendments to the Zoning By-Law planned for later this year.

## c) Environment Committee Action Plan - 2026 Budget

Staff provided an update on items in the Environment Committee Action Plan that have seen some progress over the last year and provided an overview of some of the known funding sources available to complete additional items on the Action Plan. The Committee discussed looking into developing an anti-idling policy for fleet vehicles (Action 2.2.b) and a review of the noise by-law for fireworks (Action 2.2 e.).

### d) KWRC Fall Events

Staff provided an update on events that the KWRC are holding in Hampton in the Fall. The events include:

- Soil Your Tee Shirt, Passekeag Holding, 130 Bettle Point Road, Passekeag Monday, August 25, 2025 (11 am)
- Seed Collecting Workshop, Randall Park Thursday, September 11 (time TBD) Forest ban may affect this
- Invasive Species Paddle/Clean Drain Dry Demo, River Centre Sunday, September 14 (Afternoon)
- Riverside Cleanup, River Centre Saturday October 4<sup>th</sup> (10 am noon)

## e) Battery Recycling

The Hampton Recycling Centre is anticipated to be opening Fall 2025 and will no longer be able to collect batteries in a cardboard box, which is currently used. For the battery recycling program to continue at this location, a metal container to collect batteries will be required. The Committee discussed various retailers where a container could be purchased/fabricated.



Moved by Laura Myers and seconded by Pam McKenzie to recommend that Hampton invest in an appropriate container for battery recycling container to be kept at the Hampton Recycling Centre to continue the successful battery recycling program.
