4. Business Arising from the previous Minutes:

GePeake Subdivision – Jeremy gave council update
Fireworks – Discussion around other options than fireworks, leave with Recreation Department to
come up with an alternative big draw event. Possibly 'Pretty in Pink' or other group, Shania Twain
cover, Big Fish, could be free or ticketed but low cost with the budget/grant to subsidize.

5. New Business:

- Youth Council proposal from Recreation Coordinator Discussed that PRAC is supposed to have a youth representative and we have not be able to fill it. See benefit to youth having a say but worried about the commitment and availability. Possibility of Recreation Coordinator finding a youth to join the PRAC. Jeremy indicated it would have to be a subcommittee of PRAC, and meet quarterly. Proposed it could meet as a 'think tank' or unofficial club that provides ideas that get submitted to PRAC through the Recreation Department, less formal and less red tape that way. Motion by Gail MacKinnon and seconded by Troy Summerville to recommend to council to support the concept of a youth council and work out the details for an informal club to provide ideas to be reported to council through the PRAC. MOTION CARRIED.
- Age Friendly Committee Jeremy discussed that AFC is going to disband as of December 2025 and PRAC will now pursue a Seniors Resource Centre representative to join the PRAC while we finish the current community designation term which has 2 years left.
- Committee Vacancies/PAC representative Jessica summarized the current vacancies on PRAC/PAC and Jeremy gave background on the PAC meetings and asked for members to consider it and let him know if there is interest.
- Summit Centre Tour available after the meeting if desired.

Jessica Churchill – Grand Opening and facility open, programs starting at Summit Centre, Adult hockey program success, feedback received from open skate around seniors not wanting to skate with kids (committee noted being in favour of keeping the seniors/adult and tot skate combined as open skate), Jeremy added that behaviour has been an issue in the facility and security is being explored. Committee discussed possibly bill HMHA for the additional staff requirements or have the user groups provide security for their own ice times.
