

HAMPTON SPECIAL COUNCIL MEETING NOVEMBER 4, 2025

A special meeting of Council was held on November 4, 2025, in the Council Chambers commencing at 6:16 pm and adjourned at 6:52 pm. A closed session of Council was held immediately following the special Council meeting, commencing at 6:55 pm and adjourned at 7:25 pm.

OPEN SESSION

1. CALL TO ORDER

Mayor Doucet called the meeting to order at 6:16 pm.

2. SILENT MOMENT OF REFLECTION

Mayor Doucet led Council through a moment of silent reflection.

3. APPROVAL OF AGENDA

Moved by Councillor Chorley and seconded by Deputy Mayor Salgado that the agenda of the November 4, 2025, Special Council meeting be approved as presented.

MOTION CARRIED

4. DISCLOSURE OF CONFLICT OF INTEREST

Mayor Doucet asked that anyone who has a conflict of interest declare it when they reach that item on the agenda.

5. NEW BUSINESS

5.1. 2026 Budget

Sherman St. Germain, Director of Finance & Human Resources/ Treasurer went through the 2026 budget items with Council.

5.1.1. 2026 Rates

Moved by Councillor Beach and seconded by Councillor Tompkins that Hampton Council adopt the following rates for 2026 as recommended by the Finance Committee:

Schedule A: Water & Wastewater Rates

Schedule B: Planning, Engineering & Development Rates

Schedule C: Program Registration & Facility Rates Schedule D: Hampton Student Staff Wage Scale

Human Resources Wage Scale 2026 (Presented to HR Committee)

5.1.2. Water & Wastewater Utility Budget for 2026

The Treasurer gave a brief overview of the Water & Wastewater Utility Budget for 2026 noting that there will be no increase in water & wastewater fees for the upcoming year. The breakdown of the utility budget is as follows:

Sale of Wastewater	\$ 562,960.00

Water System Expense	\$ 77,695.00
Sewerage System Expense	\$ 493,834.00
Total Expenses	\$ 571,529.00

Councillor Chorley noted that, as discussed with the Public Works & Utilities Advisory Committee, the wastewater bills will now be issued semi-annually, and he is not in favour of this change. The first bill will be sent out in January, and this can be a difficult financial time for many households after the holiday season. After some discussion the majority of Council indicated they were in favour of the change, but staff should ensure

it is adequately communicated to residents and evaluate the interest period during this transition year.

Moved by Councillor Tompkins and seconded by Councillor Trecartin that Hampton Council, pursuant to subsection 117(4) of the *Local Governance Act*, approve the total budget for the Water & Wastewater utility for 2026 which consists of total revenues of \$571,529.00 and total expenditures of \$571,529.00.

5.1.3. 2026 Tax Rate & Budget

The Treasurer gave an overview of the 2026 budget. The Finance department has been working closely with all departments to prioritize capital and operating expenditures for the upcoming year in order to present a balanced budget. Despite the property tax assessment freeze imposed by the provincial government for 2026, which will result in approximately more than \$1,000,000 of lost revenue for the local government, the tax rates for all subunits will remain unchanged for 2026.

Moved by Councillor Tompkins and seconded by Councillor Boyé that Hampton Council approve the tax rate for 2026 as follows: 443.00 (Hampton Interior) \$1.28 per \$100 assessed value, 443.01 (Norton) \$0.8085 per \$100 assessed value, 443.02 (Upham) \$0.8685 per \$100 assessed value, 443.03 (Fairmont) \$0.8085 per \$100 assessed value. For the local government of Hampton, the sum of \$14,231,851.00 be the total operating budget of the local government, that the sum of \$12,184,736.00 be the Warrant of the local government for the ensuing year, and the tax rates for the local government be as listed above. Hampton Council orders and directs the levying by the Minister of Local Government of said amount on real property tax liable to taxation under the Assessment Act within the local government of Hampton.

Capital Renewal Funding

As part of municipal fiscal reform undertaken by the provincial government, Capital Renewal Funding will be provided by the province in the amount of \$315,633.36 for 2026. These funds have been allocated to upgrades at the Mike Murphy Memorial Fieldhouse, equipment upgrades for the Public Works & Utilities Department, and infrastructure requirements for the implementation of phase 2 of the flood adaptation solutions project. The local government is required to submit a plan to the province outlining where these funds will be used.

Moved by Councillor Chorley and seconded by Councillor Boyé that the document entitled "Hampton 2026-2029 Capital Renewal Plan (CRP)" for the Capital Renewal Funding (CRF) allocation be adopted.

5.2. Incorporation of the Signage By-Law in the Zoning By-Law

Arthur McCarthy, Director of Planning, Engineering & Development, presented the proposed amendments that would incorporate the Signage By-Law as a new chapter into the Zoning By-Law. Hampton's current Signage By-Law was drafted in 2005 under the *Municipalities Act* and only applies to Ward 2. With the conversion of the *Municipalities Act* to the *Local Governance Act*, the regulation of signage has been shifted to zoning by-laws under the *Community Planning Act* (section 53(2)a(xiii)). These amendments will provide necessary updates to how signage is regulated in Hampton, create a more precise document for staff review of signage applications and provide signage standards for Wards 1 and 3.

Moved by Councillor Tompkins and seconded by Councillor Trecartin that Hampton Council set the Public Hearing date to December 9th, 2025, at 7:00 pm, in the Council Chambers, to consider amendments to Zoning By-Law No. HAM-2023-16: Hampton Zoning By-Law, related to signage. Written feedback from the public on the proposed amendments to the By-Law will be accepted until December 5th, 2025, and can be submitted via email, mail or delivered in person to the Director of Planning, Engineering & Development at Town Hall.

MOTION CARRIED

Moved by Councillor Tompkins and seconded by Councillor Beach that Hampton Council refer the draft amendments to By-Law No. HAM-2023-16: Hampton Zoning By-Law to the Planning Advisory Committee and the Economic Development & Tourism Advisory Committee for written comments to be reviewed at the Public Hearing on December 9th, 2025.
